## **RIDING CLUB RULES AND GUIDELINES**

The Waterlake Stable yard promotes safe and enjoyable riding.

Your horse/s and ponies' welfare is our concern.

All livery owners and their associates and riders as well as other Waterlake Stables Members are required to adhere to all the Waterlake stables. management published rules and guidelines at all times. These rules and guidelines will be revised and adapted from time to time and we welcome feedback and suggestions from our livery and other customers in this regard.

## **RULES AND GUIDELINES:**

- 1. NO DOGS OR OTHER PETS ARE PERMITTED ON THE WATERLAKE STABLES PREMISES
- 2. No riding will be permitted on the W.S. premises unless a riding hat of approved (SANEF) and current safety standard is worn at all times whilst mounted.
- 3. Sensible foot wear according to international standards is required if mounted on the W.S. premises.
- 4. Please display consideration for the safety of other riders, horse handlers, spectators, pedestrians and home owners.
- 5. Please show respect for our premises.
- 6. No trotting, cantering or galloping of horses /ponies is allowed in any horse handling areas excepting for veterinary purposes.
- 7. Use of all lunging, riding and loose schooling arenas is to be coordinated with the management and to be undertaken within strict safety guidelines.

- 8. No lunging arenas or other arenas are to be entered on foot or horseback without permission when a lesson is in progress.
- 9. All instructors and trainers are required to work within strict Waterlake stables safety guidelines at all times.
- 10. Use of all jumping equipment is strictly at the risk of the individual and should be arranged with the W.S. management.
- 11. No grooming staff will be available for any duties before 7h30 am and after 16h30 pm daily unless by specific arrangement with the management.
- 12. W.S. will be open from 7h00 till 19h00 from Sept to April and from 07h00 till 18h00 from May to August. No horse owner or visitor will be allowed to be at the stables after 19h00. All lights must be switched off by the last livery owner.
- 13. Riding lessons will not be booked later than 18h00 to insure that all horses are cooled and fed before 19h30.
- 14. In the event of an injury or a sick horse, the vet, W.S. management and the livery owner will be allowed to have access to the stables and horses at all times.
- 15. All tack and other equipment must be locked away in the tack rooms when not in use. Management reserves the right to deny the use of facilities if tack or equipment is considered unsafe.
- 16. If for any given reason the Stable complex/block is being visited by a non livery owner or estate agent, an appointment must be made with W.S. management, to prevent an injury to person and /or horse.
- 17. Management reserves the right to allocate the use of paddocks for horses and ponies.
- 18. The amount of foodstuffs and bedding allocated to each horse / pony, including concentrates, hay, Lucerne or sawdust/ shavings and straw may not be altered by anyone other than management.
- 19. All worming of horses will be co coordinated by management at the cost of the horse / pony owners. Livery customers may provide their own wormer if they wish to do so which will be administered by the management in line with yard policy.
- 20. In case of an emergency and the livery client or the livery client's vet is not immediately obtainable; any vet may be called in at the cost of the livery client.
- 21. All vehicles must park outside the stable, on the most eastern grass area. Access to the stables parking is giving by travelling around the back of the stable complex/block.
- 22. Horseboxes must be parked in allocated area as soon as the horse is off-loaded.

- 23. Waterlake Stables, its employees or representatives will not be held responsible or liable for any personal injury, death or damages caused to any person, horse or equipment whether by negligence or wilful act by the Centre, its staff or any other person.
- 24. All young children should be properly supervised by an adult at all times on the W.S. property.
- 25. Livery clients do not have the privilege to use the picnic areas and/or the gym.
- 26. All livery clients, pupils and visitors to W.S. are required to adhere to all rules of Waterlake Farm security.
- 27. Access will be gained according to the same rules that apply to a visitor entering Waterlake farm to visit an owner, in this case the stable owner.
- 28. Livery clients who gain access to Waterlake Farm are obliged to travel to and from the stables via the shortest and most direct route possible (I.e. sightseeing, loitering or any deviation from this route whatsoever is not allowed)
